RULES AND REGULATIONS OF THE NATIONAL CLAY SHOOTING CENTRE

1. I have read and will abide by the NRA\*/NSC\* Range Regulations.

2. I am not prohibited from possessing a Shotgun or ammunition under Section 21 of the Firearms Act 1968 as amended (i.e. I have not been sentenced to a term of imprisonment exceeding 3 months).

3. I have never had an application for a Shotgun certificate refused by the Police, or had a certificate revoked (or I have enclosed full details of any revocation in a sealed envelope).

4. When in possession of a Shotgun on the complex (whether you are member or non-member, whether it is your own or hired from the club or whether it be under supervision or on an individual shoot) you are wholly responsible for that firearm and the NCSC, NSC and NRA will not be responsible for its theft or loss.

5. As a member I am eligible to fire at a discounted rate (ie for 2020 £6.50 (including VAT) for 25 clays excluding cartridges £7.50 for non-members. **This discounted fee does not count towards Corporate Hospitality, Guest day activities or personal guests.** The discount does count, in part, towards my own one to one tuition.

6. Membership will be deemed to have lapsed should I not renew by the 1<sup>st</sup> of the month that I joined in the following year and non-discounted shooting rates will then be applicable.

7. Alcohol is not to be consumed on the ranges at any time.

8. The complex will be open for telephone bookings / enquiries from Tuesday to Sunday inclusive from 9am until 5pm. If I do attend the facility without first checking availability by phone the centre cannot guarantee that I will be able to shoot as the ranges may be booked for Courses, Corporate Hospitality or Competitions.

9. The complex is CPSA registered therefore I will adhere to all CPSA rules and regulations throughout the complex and at all times.

10. Eye protection must be worn for all registered shoots and as directed by NCSC Staff.

**GENERAL INFORMATION**

We will also be rewarding members who shoot County or Regional events (at which we are not permitted by CPSA rules to charge members a lower entrance fee than non-members). We will award a loyalty silver shooting token to each member shooting a county or regional competition. It is the members responsibility to request there free token at the time of paying their entry fee to the competition. This will allow members to shoot one free round of trap or skeet at a time of their choosing. Additionally if you purchase 10 tokens in one transaction (£65.00) we will give you one token free.
